Open Issues

1. Dr. Sunita Adhav stated the commencement of first-year BALL.B and LL.B, has started that online lectures have commence from the month of March or April.
2. Dr. Ananya Bibave informed to all the members of the IQAC that the IIQA for the second cycle of NAAC has been successfully submitted and the College has already begun the process of writing the SSR.
3. Adv. Dr. Chintamani Ghate informed all the staff members that the additional infrastructural recommendations have been accepted and the Management has approved the quotations for them. The works of the infrastructural changes will begin soon.
4. The Criteria wise allotment of work was also discussed by Dr. Ananya Bibave which was approved by the members
