## Approval of Minutes from the last meeting

The minutes of the previous Meeting of IQAC held on Monday, 27th September 2021 were read out by the Coordinator of IQAC. It was unanimously resolved to recommend the confirmation of the minutes of the previous meeting.

## **Open Issues**

- 1. Adv. Dr. Chintamani Ghate stated that it is difficult to conduct an offline 16th Shankarrao Kanitkar National Moot Court Competition and the college should consider conducting an online moot court competition in the month of April.
- 2. Dr. Sunita Adhav also stated the status and commencement of first-year BALL.B and LL.B, she also mentioned that online lectures shall commence from the month of March or April.
- 3. Dr. Ananya Bibave confirmed the need for the continuation of e-Newsletters so that the students and all the stockholders get easy access to college news and events.
- 4. Asst. Prof. Shivanjali Bhoite stated that Feedback Analysis should be made and the following feedbacks need to be examined along with Action Taken Report:
  - 1. Students Feedback about College and Curriculum
  - 2. Alumni Feedback about College and Curriculum
  - 3. Teacher's Feedback about College and Curriculum
  - 4. Employer's Feedback about College and Curriculum
- 5. Dr. Sunita Adhav stated the need for a Standard Operating Procedure during the COVID-19 (second wave) outbreak, and precautions needed to be taken during the upcoming months.
- 6. Dr. Abhijeet Dhere stated the importance of e-content preparation and regular updation of the college website/ Google Classroom etc. for the students.
- 7. Prof. Shamkant Deshmukh mentioned the need to strengthen the college's placement cell.
- 8. Dr. Ananya Bibave discussed the Students Satisfaction Survey conducted by the college and stated that teachers should discuss student's performance in their respective assignments, help students with emotional and social, and make maximum use of ICT and multimedia tools while teaching; she also stated the need of strengthening the Placement Cell.
