





Dr. Priyanka Jawale was also selected by the United Nations Office of Outer Space Affairs (UNOOSA) to work as a UNOOSA rapporteur in the United Nations/Turkey/APSCO Conference on Space Law and Policy at Istanbul, Turkey in Sept. 2019. Dr. Jawale also spoke on 'nuclear and innovation' at the International Youth Nuclear Congress at Sydney, Australia (March 2020). She is an active member of International Nuclear Law Association and Indian Nuclear Law Association since 2017. She is also a member of Indian Society of Criminology. She works in the area of science-technology, Law and policy, Socio-legal Research Methodology, futuristic areas in legal field and many more.



Dr. Priyanka Jawale gave a brief introduction about the concept of space and the laws relating to space. Jawale ma'am conducted a very interactive lecture. Ma'am shared a few videos from YouTube with regard to ISRO and space debris. Ma'am answered the queries of the students and had the students in a trance of space law throughout the lecture.

also completed the Winter School Certificate Program on Cyber Security and Cyber Law at Gujarat National Law University, Gandhinagar and was awarded as the Best Participant for the same in 2012. He was invited in Berlin School of Economics and Law, Berlin (Germany) in 2015 to deliver sessions on Police Law and Constitutional Law.



Dr. Shrikant Malegaonkar is a specialist in Labour Laws and Industrial Relations & is practising Advocate at Pune Labour/Industrial Courts and at the Bombay High Court, for the past 28 years. His Consultancy is by name, "Malegaonkar & Associates" engages in Litigations, Consultations & Training in Labour Laws for Indian and Multi National Companies, along with Criminal Law and Commercial litigation as subsidiaries. In England, Sir delivered lectures in Employment Law at The London School of Economics, London, The School of Oriental and African Studies, London, at The University of Maiduguri, Nigeria, and at The Peoples Institute, Histadrut, Israel besides pursuing academics at the Berlitz School of Languages, London. Completed his Masters Degree in Law (LL.M.) with flying colours and then started his practice at the Bar & is recipient of the 'Setalvad Prize' from, The Bar Council of Maharashtra.

The lecture on the fifth day focused on the aspects of Labour Law especially considering the aspects of career in labour law. Sir introduced to all the students the various opportunities that are available to them in labour law. Adv. Malegaonkar sir focused on the ground reality in practice in the labour law area. He also discussed the various approaches that you can have towards labour law.

Report on visit to National Lok Adalat

Venue: - District and Session Court, Shivajinagar Pune

Date: - 11-12-2021

The concept of Lok-Adalat is a unique Indian contribution to the prudential jurisdiction. In India, the notion of Lok-Adalat means "people's court," as the name suggests. At the local level, these systems are known as 'Panchayats' in India, and they have a long heritage and history of being used in society at the ground level or the early level. It has shown to be a very effective alternative to courtroom litigation. The 'peoples court,' also known as the 'Lok Adalat,' is an older concept of resolving conflicts by mediation, negotiation, or an alternate arbitral method. They exist to relieve the judiciary of some of its burdens.











The goal of the visit was to have a better understanding of how a court works and the nature of judicial employees' responsibilities in Lok Adalat cases. To comprehend how the old Indian culture of conciliation and dispute settlement in the form of Nyaya Adalat or Gram Panchayats led to the creation of Lok Adalats, which introduced a new chapter to the country's justice dispensation system. How does it give a secondary platform for victims to resolve their disputes in a satisfying manner?

The tour gave the students a better understanding of how the Lok-Adalat works and how it serves the people, both in terms of the benefits and the disadvantages that the parties had to deal with as a result of the court's unavoidable faults. The pupils saw a one-of-a-kind and efficient judicial legal system.

The Pune District Court held a Lok-Adalat at Shivajinagar court on February 8, 2020, starting at 10.30 a.m. Thirty LLB-II students and college faculty member Assistant Professor Mr. Akshay Ugale gathered on the court for the Adalat.

Following the attendance routine and a brief explanation of the process, students were sent to the court's information section, which exhibited all of the cases scheduled for hearing today. Cases were separated into types and sent to different courtrooms. Students were asked to form groups of three to four people. After the initial group assignment, each group was assigned to a courtroom where they would attend the hearing; students were sent into their respective courtrooms where they attended cases pertaining to the Indian Contracts Act 1872, Civil Procedure Code 1908, Indian Penal Code, Arbitration and Conciliation Act 1996, and others.



Report on visit to National Lok Adalat

Venue: - District and Session Court, Shivajinagar Pune

Date: - 12-03-2022

The students of Modern Law College, Pune visited the National Lok Adalat conducted in the Shivaji Nagar Court premises on 12th of March, 2022. A Lok Adalat is organized by the directions of Hon'ble Apex Court for speedy disposal of the cases and to reduce the pendency and burden on the Trial Courts.

National Lok Adalat disposed off more than 14.97 lakh cases in 1 day. Of these 7.33 lakh cases were pending cases, whereas the remaining 4.64 lakh cases were at a pre-litigation stage. The cases involved all types of civil, criminal, consumer, labour matrimonial matters as well as cases under the Motor Vehicles Act. The total settlement amount arrived at in all the cases, was to the tune of \$\square\$3217 crores.

A Lok Adalat is organized every 3-4 months where matters are settled making the parties to arrive at a mutually agreed settlement between themselves, thereby saving years of litigation and cost incurred thereby. A team of 30 students of LLB First year students alongwith Asst. Prof. Prajakta Pimpalshende and Asst. Prof. Vikas Waghmare attended event.

.Following the attendance routine and a brief explanation of the process all the students attended Inauguration ceremony at Ashoka Hall. After the Inauguration ceremony students got opportunity to talk with Hon'ble Judges this was a very happy and memorable moment for them.





With these, the lecture went towards the question & answer sessions, where all the attendees posed their questions regarding the current scenario of India and Covid -19 with its impact on them.



Report: Kanitkar Day


Date: 25 January 2022

The aim was to "Acknowledge, appreciate the students."







Vidhirang 2022 Report


