Date

1. Dr. Sunita Adhav, (Principal) Chairperson: Head of the Institution, discussed the NAAC work allotment which was allotted previously.
2. As the SSR was accepted and our college reached the pre-qualifier stage of NAAC, the dates were confirmed for NAAC peer team visit i.e. 20-21st January, 3-4th February, 17-18th February.
3. Dr. Ananya Bibave, IQAC coordinator stated that the documentation work of NAAC should be speeded up without affecting the academic work.
4. The IQAC coordinator suggested for publishing handbooks of various subjects prepared by the staff.
